⁵ **“Placement Rate”** is calculated by dividing the number of graduates gainfully employed in the field by the number of graduates available for employment.

⁶ **“Total Graduates Employed in the Field - within one year of graduation”** means graduates who report that they gainfully employed within one year of graduation in a position for which the skills obtained through the education and training provided by the institution are required or provided a significant advantage to the graduate in obtaining the position.
